#### MINUTES OF THE MEETING

1. OPENING PRAYER: MS O. JOSEPH

## 2. WELCOME REMARKS

The chairperson, Mr. Isiah Tshegofatso welcomed everyone to a meeting. He thanked members for their dedication and commitment to drive the mandate of the society. He indicated some challenges faced in year 2020. Most of the activities planned were affected by the outbreak of the Covid-19. He also reminded members the objectives of the society.

The primary objective of the society as stipulated on the constitution are briefly:

- ❖ To promote sustainable development in the village by volunteering in community projects that need involvement of Morafe and also interact with the village elders to come up with ideas that can uplift the live hood of the community at large.
- ❖ To promote good morals among the youth by educating them on gender violence, drug abuse, curbing of alcohol drinking and promote the spirit of Botho.
- ❖ To promote spirit of self-reliance among the youth by imparting good entrepreneurship skills among the youth to venture into small business and take advantage of youth empowerment polices/ programmes provided by the government.

# 5. ACTIONS ARISED FROM PREVIOUS AGM

## **Fundraising Committee**

In the last AGM the chairperson of the fundraising Mr. Gaobonale reported that the committee has done some fundraising activities. Some of the planned activities did not continue as planned due to various reasons. He further explained that the committee has a challenge since some of the stock that were procured to be sold were stolen while in one of the member's custody. The committee has identified the culprits and the matter was reported to the police. While presenting the

financial statement, the statement were not easy to be understood by members. The financial statement was complex and confusing hence the members decided not to accept the fund raising report. The committee members were advised to finalize a report and present the report to the members. The members also wanted the committee to account for the funds that were pledged by members.

## Resolution:

The fundraising members agreed to pay P960 to compensate for the loss.

## 6. ANNUAL REPORT

The Secretary, Mr. N. Nkaelang presented the report to members

## I. SECRETARIANT OFFICE

- **a.** The committee has opened a box number at Thabala Post Office. An amount of P600 was paid to the post office.
- b. A stamp was bought P250
- c. The members of the EXCO has not used any funds to do an administrative while in most of the activities they were using their funds. Only P400 was spent on team that went to buy Kitchen utensils.

# II. Memorandum of Understanding

- a. A memorandum of understanding was signed with Thabala Primary School on the 27<sup>th</sup> November 2020.
- III. TPSG donated the buckets that cost P4000 on the 27<sup>th</sup> November 2020.
- **IV.** Handover: The committee handed the fence to the beneficiary of Thabala Primary on the 31 July 2020.

#### a. DONATION TO HOME BASED CARE

- The society received 20 schools bags(10 small bags and 10 big ones) for kids from Mr. and Mrs Othusitse. There were donated to Thabala Primary School on the 11<sup>th</sup> December 2020.
- II. During the month of May, a donation of foods was received from anonymous sponsor at a total cost of P5935 and the foods was distributed to home based teams. This was in consultation with Thabala Health Clinic.

#### III. APPRECIATION OF DONORS

The committee has issued the certificate of appreciation to the companies that donated to the society.

# REGISTRATION OF MEMBERS SUBSCRIPTION FEES

The society registered 93 members all have paid subscription fees. Only 77 members have paid annual subscription fees.

## **CHALLENGES**

#### a. COVID-19

The committee has not been able to execute some of the yearly activities as planned because of the pandemic. As a result this disrupted some of the activities, e.g Areitsaneng was cancelled, fund raising activities were also affected.

# b. Society Questionnaire

A questionnaire was developed and administered among members. Unfortunately the members did not partake to answer the questionnaire. Only 13/89(15%) participated.

- **c. Annual Returns**: Annual returns for the past years were not submitted to register of the society.
- **d. Strategic Plan**: The committee has not finalized the strategic plan. In the last AGM 2019 it was reported that the facilitator decided to withdraw because of lack of commitment from members to fill the questionnaires.
- **e.** Launch of the society: the society has not been launched.

## **Comments from members**

**Publicity:** Members were concerned that only few know about the society, therefore society need to be publicized to the community.

**Memorandum of Understanding:** Some members asked whether the 80% average target is achievable. It was explained that the school has similar target. However, the head teacher was bit skeptical that the target might not be achieved in 2020 due to Covid-19

**Subscription fees:** All members paid joining fees except few who have not paid annual subscription fees. Those who have not paid annual subscription fees were encouraged to pay.

**Questionnaire:** a questionnaire was shared with members and only few contributed. The committee were advised to encourage members to contribute once an issue is brought to the table. It was observed that the spirit of volunteerism was fading among the members.

**Anonymous:** Members raised alarm about donation received from anonymous. There were various reasons raised such as money laundering and political maneuvering. As a way forward the committee will introduce a template for accepting the donations.

## 7. FINANCIAL REPORT

The financial report was not presented because treasure was not in attendance. However, it was agreed that the report will be shared among the members. The questions that might arise from the report will be addressed in April 2021.

## 8. FUNDRAISING COMMITTEE

The chairperson reported that the committee members has pledged P1300 to source the musk. The tailor was paid P1100. A total of 90 musk was made. He was not happy by the shoddy job that was done by embroider. The society did not make an anticipated profit because some members requested to be reimbursed. Some members have not paid for merchandise. The society has an outstanding balance of P729.

#### Comments

The committee was advised to have target during their initial planning. The committee should also consider empowering the local community by engaging and buying from them.

- 4) If a member is hospitalised for at least 5 days s/he shall be entitled to a fruit basket P200.00 from the society coffers
- 5. If one/ more members lose a parent P25 shall be contributed towards their lose in the form of matshidiso.
- 6. The above shall only apply to a member who has fully paid their membership fees.
- 7. The above shall not be extended to members who are at defaults or never contributed for others
- 8. Secretariat shall keep records of such contribution and keep filed.
- N.B: The matshidiso shall be handed to the bereaved family 7 days after the funeral.
